

FOMC holds in December, remains committed to bringing inflation down to 2%

The December 13, 2023, Federal Open Market Committee (FOMC) Policy Statement:

- Labor Market and Inflation
 - Recent indicators suggest that growth of economic activity has slowed from its strong pace in the third quarter. Job gains have moderated in recent months but remain strong, and the unemployment rate remains low.
 - Inflation remains elevated.
- The Federal Funds Target Range
 - The FOMC decided to maintain the target range for the federal funds at 5 ½ to 5 ½ percent. The FOMC will continue to assess additional information and its implications for monetary policy. In determining the extent to which additional policy firming may be appropriate to return inflation to 2 percent over time, the FOMC will take into account the cumulative tightening of monetary policy, the lags with which monetary policy affects economic activity and inflation, and economic and financial developments.
- Monetary Policy
 - The FOMC will continue to monitor the implications of incoming information for the economic outlook and would be prepared to adjust the stance of monetary policy as appropriate if risks emerge that could impede the attainment of the FOMC's goals. The FOMC's assessments will take into account a wide range of information, including readings on labor market conditions, inflation pressures and inflation expectations, and financial and international developments.
- Credit Conditions
 - The U.S. banking system is sound and resilient. Tighter financial and credit conditions for households and businesses are likely to weigh on economic activity, hiring, and inflation. The extent of these effects is uncertain.
